Please accept this letter as a response to your correspondence dated September 16, 2014. The enclosed CD contains data related to portions of your request as articulated below. As indicated in the MPD's response letter dated September 30<sup>th</sup>, 2014, only a portion of the records you requested are being provided at this time. The process of gathering and redacting the remaining portion of your request continues. The disk has four files: MPD-Tiburon FI and Consent Search, MPD CMS-Arrests, MPD CAD-Subject Stops, MPD CAD-Traffic Stops.

**FI and Consent Search:**

File contains Field Interviews from January 1, 2008 through April 14, 2014 and Consent Search Forms entered June 2, 2013 through April 14, 2014 (when data collection began). The FI data and Consent Search Forms are pulled from the FI module of the Tiburon system and are listed on the CD as "MPD Tiburon FI and Consent Search." This data is responsive to the following portions of your request:

2. All records created since January 1, 2008, documenting the total number of:
  - a. Stops, also known as "field interviews", conducted by the MPD between January 1, 2008 and the date of this request;
  - e. Consent searches conducted by the MPD between January 1, 2008 and the date of this request, and the number of such consent searches that resulted in the recovery of contraband disaggregated by contraband type; **Note: The electronic Consent Search field has a "yes/no" check box indicating whether contraband was recovered from the search but does not collect the type of contraband recovered.**
4. All records, including, but not limited to, Field Interview cards created since January 1, 2008, collecting information about each stop, frisk, and search conducted by the MPD, including records identifying the following for each incident:
  - a. The location or address of the stop, frisk, and/or search; **(Loc column)**
  - b. The date of the stop, frisk, and/or search; **(Rpt\_ Date column)**
  - c. The duration of the stop, frisk, and/or search, or in the alternative, the time that the stop, frisk, and/or search was initiated and the time that it concluded; **Note: Field not captured/no responsive record.**
  - d. The race, ethnicity, gender, national origin and/or age of the individual(s) stopped; **Note: Fields for ethnicity and national origin are not captured/no responsive record.**
  - e. The basis for the stop, including any description of the circumstances leading to the stop; **(Reason column)**
  - f. Whether any frisk was conducted and the basis for the search, including any description of the circumstances leading to the search; **Note: Field not captured/No responsive record**
  - g. Whether any frisk resulted in the recovery of contraband, and the nature of any contraband recovered; **Note: Field not captured/No responsive record**

- k. The badge number jurisdiction of the law enforcement officer(s) who completed the form. The officer's unique identifier number was provided. (**Officer column**) *Note: badge number is not used, officers identified by People Soft number.*

#### **CMS Arrest**

File contains arrests for the date range of January 1, 2008 through April 14, 2014. This data is provided and listed on the CD as "**MPD-CMS Arrests**". This data is responsive to the following portions of your request:

- 2. All records created since January 1, 2008, documenting the total number of:
  - f. Arrests, disaggregated by age (DOB provided), race, and gender, made by the MPD between January 1, 2008 and the date of this request, and the offense(s) for which each arrest was made.

#### **Computer Aided Dispatch System**

File contains subject stops for the date range of January 1, 2008 through April 14, 2014. Additionally, traffic stops and targeted traffic stops for the date range of January 1, 2008 through April 14, 2014. The data excludes duplicate and cancelled calls. Due to the volume of data, this part of the request was separated by the two subjects and listed on the CD as "**MPD-CAD Subject Stops and MPD CAD Traffic Stops**." This data is responsive to the following portions of your request:

4. All records, including, but not limited to Computer Aided Dispatch System, created since January 1, 2008, collecting information about each stop, frisk, and search conducted by the MPD, including records identifying the following for each incident:


- a. The location or address of the stop, frisk, and/or search; (**SZLocation column**)
- b. The date of the stop, frisk, and/or search; (**LTCreated column**)

- d. The race, ethnicity, gender, national origin, and/or age of the individual(s) stopped; *Note: Field not captured/No responsive record*

- f. Whether any frisk was conducted and the basis for the frisk, including any description of the circumstances leading to the frisk; *Note: Field not captured/No responsive record*
- g. Whether any frisk resulted in the recovery of contraband, and the nature of any contraband recovered; *Note: Field not captured/No responsive record*
- h. Whether any search was conducted and the basis for the search, including any description of the circumstances leading to the search; *Note: Field not captured/No responsive record*
- i. Whether any search resulted in the recovery of contraband, and the nature of any contraband recovered; *Note: Field not captured/No responsive record*
- j. Whether the stop resulted in an arrest, citation, or no further action, and the basis for any resulting arrest or citation; (**SZDisposition column**)
- k. The badge number and jurisdiction of the law enforcement officer(s) who completed the form. *Note: Field not captured/No responsive record*

*Column(s) listed as "Null," a search was conducted for data and the field was blank. The Milwaukee Police Department does not collect data using the word "frisk" within any database system. To assist you in understanding the final dispositions of the CAD calls, a copy of the C-Codes and their meaning will be included with your request.*
