**SECOND DECLARATION OF SALLY T. HILLSMAN**


I, Sally T. Hillsman, of Washington, D.C., do declare:

1. I am the Executive Officer of the American Sociological Association (“ASA”).
2. In a declaration I submitted on February 13, 2008, in support of plaintiffs’ motion for summary judgment in this case, I fully described ASA’s efforts to secure Professor Adam Habib’s attendance at prior ASA Annual Meetings, *see* Declaration of Sally T. Hillsman at ¶¶ 18-22, 24-26; why it is important to ASA and its members to engage with Professor Habib at U.S. events, *see id.* ¶¶ 16-17, 19, 24; and Professor Habib’s deep ties to the political science and sociology academic communities in the United States, *id.* ¶ 17.
3. Professor Habib remains one of South Africa’s leading scholars and political commentators on issues of democracy, human rights, and social movements. He is a widely-respected thinker whose views and research continue to be of utmost importance to the sociology community in the United States. Because the ASA Program Committee continues to believe that it is important for its members to have an opportunity to hear Professor Habib’s ideas and engage

him in face-to-face debate, the ASA has invited Professor Habib to speak at its next Annual Meeting, which will be held in San Francisco from August 7-11, 2009. The theme of this year's Annual Meeting is "*The New Politics of Community*." Professor Habib has been invited to speak on one of our select Presidential Panels entitled "*Building a Global Social Justice Community: Africa and Human Rights*." The panel will focus on human rights initiatives in Africa. Although there is a growing interest amongst U.S. social scientists in studying global human rights initiatives, initiatives in Africa have received scant attention within the American sociology community. The panel seeks to rectify that gap and explore how an increased emphasis on human rights in Africa might inform American sociology.
